MEMORANDUM OF UNDERSTANDING

This Memorandum of Association has been made and executed at Raigad district, Maharashtra, on the 03rd day of September, year 2020.

BETWEEN

Group Gram Panchayat of Devlohi, with its office at Devlohi, through its Sarpanch, Mrs. Mnasvi Manoj Bhandarkar, (hereinafter called the party of the First Part or the First Party);

AND

Pillai HOC College of Arts, Science and Commerce, Rasayani, Maharashtra, affiliated to University of Mumbai, approved initially at 2008, having its campus at Rasayani, Raigad, through the Principal of the Institute (hereinafter called the Party of the Second Part or the Second Party).

WHEREAS the first party is a Group Gram Panchayat of Devlohi, Taluka – Panvel, District - Raigad.

AND WHEREAS, the party of the second half has been established under educational institution under University of Mumbai, to provide for education and research in various branches of Sciences and Arts thereby, disseminate knowledge.

The purpose of the MOU is to establish the basis and structure of collaboration between Pillai HOC College of Arts, Science and Commerce, Rasayani and Group Gram Panchayat of Devlohi to undertake activities of the Unnat Bharat Abhiyan (UBA) Activities of Pillai HOC College of Arts, Science and Commerce, Rasayani in different areas of Devlohi.

Objectives:

To extend our UBA activities for the overall development of the students and instilling the concept to clean, protect and preserve the environment based on the campaign by Government of India, Ministry of Human Resource Development (MHRD)- Rural Education and Health and Sanitation.

That Group Gram Panchayat of Devlooli shall assist in organizing socially useful events with UBA Volunteers of the college. The programme schedule, date and timing of the same shall be decided with mutual consent of the authorities concerned.

That Group Gram Panchayat of Devlooli shall assist the college UBA volunteers in organizing grass root level exposure by inviting eminent social workers and technical experts from time to time to promote their capacity building and skill development. The college on the other hand, would extend all possible support for mutually beneficial socially relevant community activities.

That Group Gram Panchayat of Devlooli shall do all the necessary arrangements including food during the entire period of camping and other activities.

Thus, Group Gram Panchayat of Devlooli and Pillai HOC College of Arts, Science and Commerce, Rasayani have agreed to be in support of their mutual interests in the field of education and social service.

The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration.

The other clauses include

- That in case of any dispute or differences between the Parties, the decision of the Principal of the Institution shall be final and binding on the both parties.
- That no other activities involving the students of the institution shall be undertaken by the Group Gram Panchayat of Devlooli without the prior approval of the Principal of the Institution.
- That the Institution shall not be responsible directly, indirectly or vicariously in respect to any act, commission or omission committed by Group Gram Panchayat of Devlooli whether on the campus or the repercussion thereof may take elsewhere. It shall be the sole responsibility of the Sarpanch of Group Gram Panchayat of Devlooli to deal with the unforeseen or untoward circumstances arising with the collaboration
- That under no circumstances, the Institute shall be responsible or answerable for any injury claim, compensation or award of the Court or Statutory Authorities.

Pillai HOC College of Arts, Science and Commerce, Rasayani, shall not hold liable for any damage that is caused directly or indirectly during social activities.

This agreement will take effect from the date of its signing and shall be valid for the period of one year from that date unless sooner terminated, revoked or modified by mutual written agreement between two Parties, and may be extended by mutual written agreement.

Either party may terminate the Agreement at any time during said term by the provision of three months written notice to the other party.
